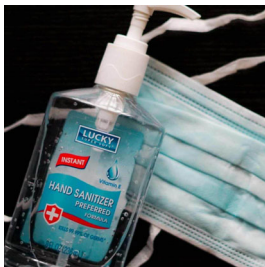

#### [Important COVID Update](#)

With the new Test, Trace, Isolate and Quarantine (TTIQ) model being introduced in South Australia and the borders now being opened, it is now more important than ever that we follow good Covid protocols. QR Check in is required on entry to the market. Wearing of masks in the pavilion is **Mandatory** for all unless a valid exemption is held. **Eating & drinking is NOT permitted** inside the pavilion to prevent masks being removed. We ask all stalls serving food or beverages to remind customers of the requirement to leave the pavilion before their purchases are consumed. Wearing of masks outside is highly recommended. **ALL** stallholders are required to have hand sanitiser available and within easy reach for customer use at all times.

A reminder that all products sold at your stall must have pre-approval from the ASFM to be sold. Applications for new products can be made easily by completing the appropriate [product approval form](#) and sending to [crobertson@adelaidefarmersmarket.com.au](mailto:crobertson@adelaidefarmersmarket.com.au). They may take more than a



week to process, so please allow plenty of time if you have a planned launch date. Please note: Not all applications will be approved.



#### MARQUEE Weights

Again we remind you that ALL outdoor marquees MUST have all legs weighted or securely tied off to a fixed object like a car or heavy tree. Marquee weights must not be removed from the legs or marquees dismantled until the market has officially closed. The safety of other stallholders and shoppers is paramount and should be a priority in your set up and bump out routine.



#### Stallholder CARPARK

Numerous stallholders are still parking in the customer carpark. On a recent week a stallholder even parked their van in a disabled carpark and left it there well into market trading time!! There is more than adequate parking for all stallholders and their staff in the stallholders carpark and along the Western Boulevard. Please leave all carparks in the Rose Tce carpark for customers. Given how busy it will get in the lead up to Christmas its really important that they have as many parks as possible to access.

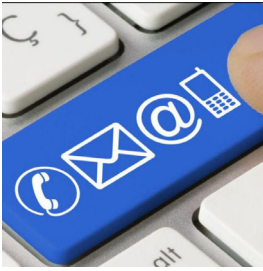


#### TWILIGHT Market
