POWER CORDS

The power cords running from stalls to distribution boxes behind marquees inside the pavilion are to say the least 'like a dogs breakfast'!!! The area behind the stalls on the southern side needs to be kept tidy and safe at all times and is not a thoroughfare for stallholders. Last week, someone knocked an extension cord from a power board and a stallholder lost a freezer full of stock at great cost. That's not okay. Each stallholder is allocated one x 15amp power socket (unless otherwise agreed with management). If multiple items need power, then you need to supply your own 15amp power board. Cords need to be kept neat and tidy and run along the back of the stalls. Thanks in advance for your cooperation to get this area tidied up.



BLINDS

The ASFM are installing Indoor UV sun block blinds on the windows at the Eastern end of the pavilion this week. This will be a welcome relief to the bright sun and heat that enters the pavilion via those windows during the summer months. Please make sure you move **ALL** equipment and stall furniture well away from the windows so that installation can go ahead without obstruction. Thank you in advance.



STALL PACK UP

We have noticed a number of stallholders are starting to dismantle their stalls and pack up well prior to the close of the market. It is a requirement that **ALL** stalls remain set up until after the closing bell rings as per our Stallholder Rules.

3.3.4. Other than for reasons of safety, Stalls cannot be dismantled until the close of the Market unless prior approval has been given by the Operations Manager.
